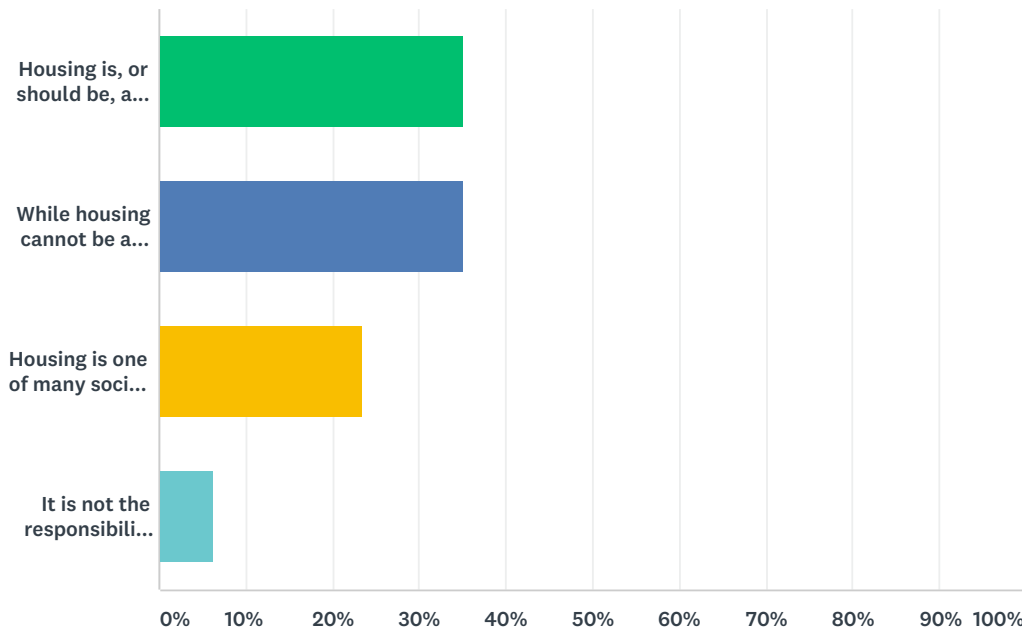


Q1 Which of the statements best captures your opinion about the country's responsibility towards housing?

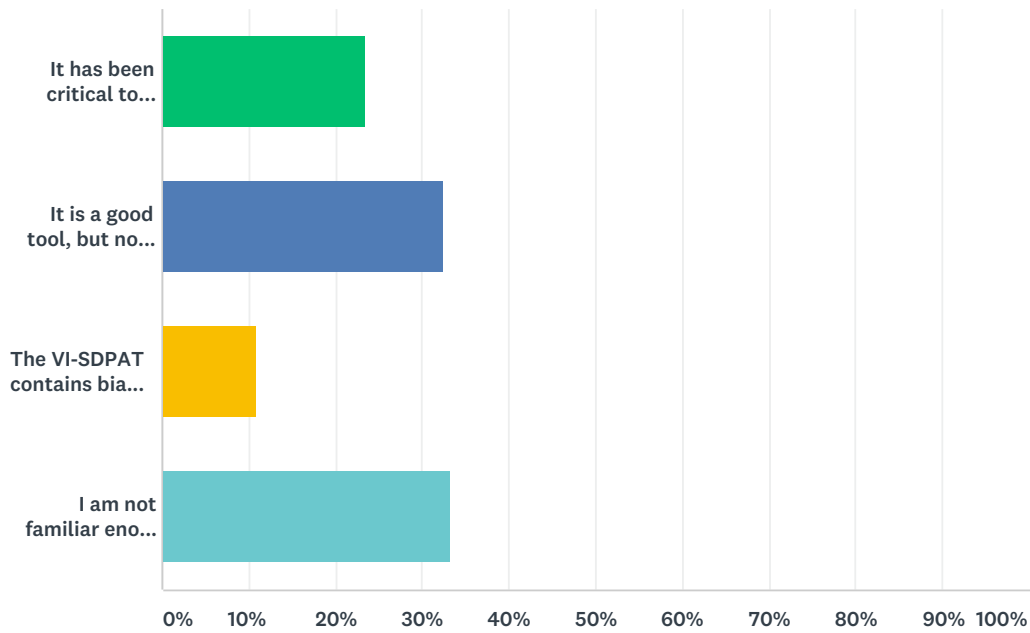

Q2 Which of these statements best describes your assessment of the VI-SPDAT initiative?

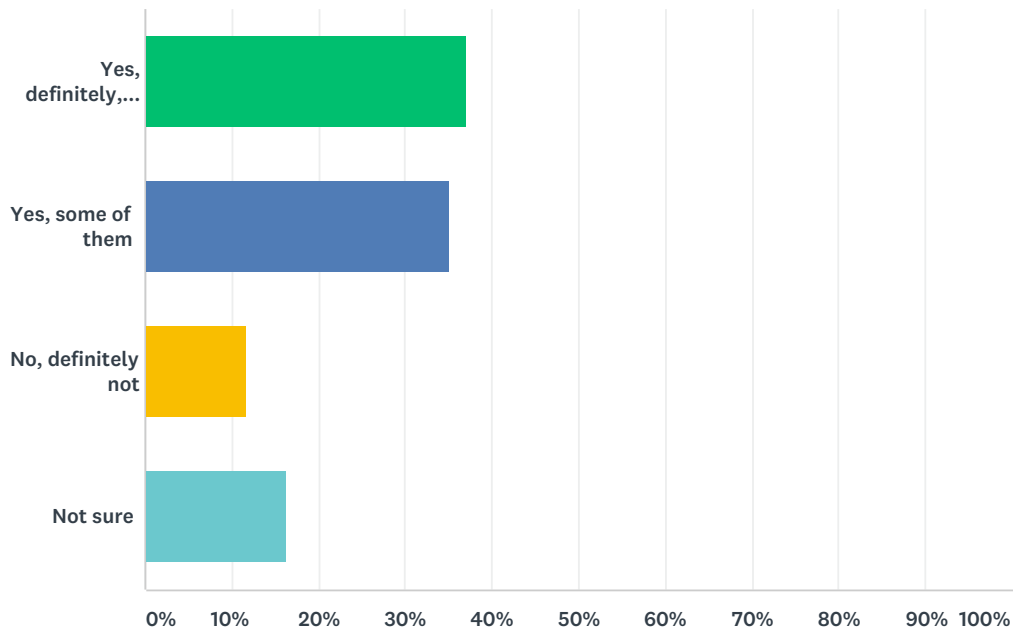

Q3 Do you support the conversion of Transitional facilities into Permanent Housing?

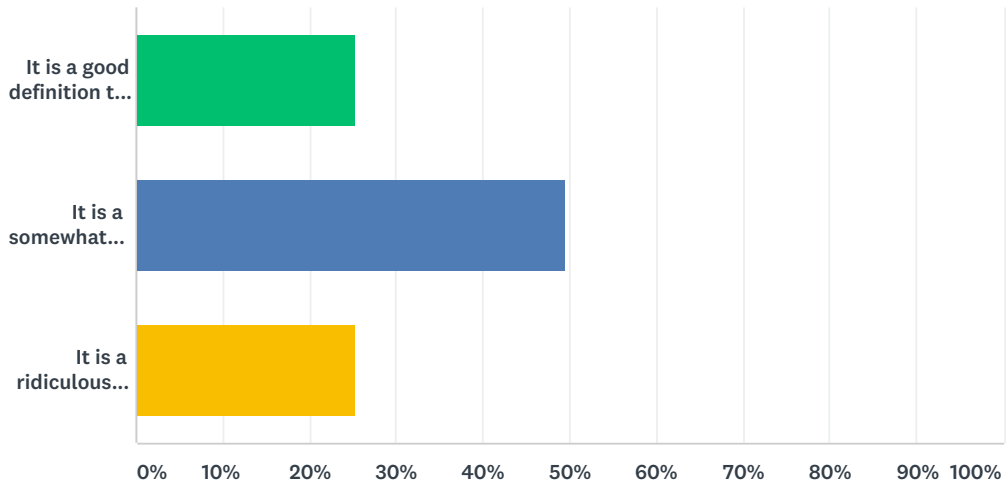

Q4 What is your opinion of the Chronic Homeless definition?

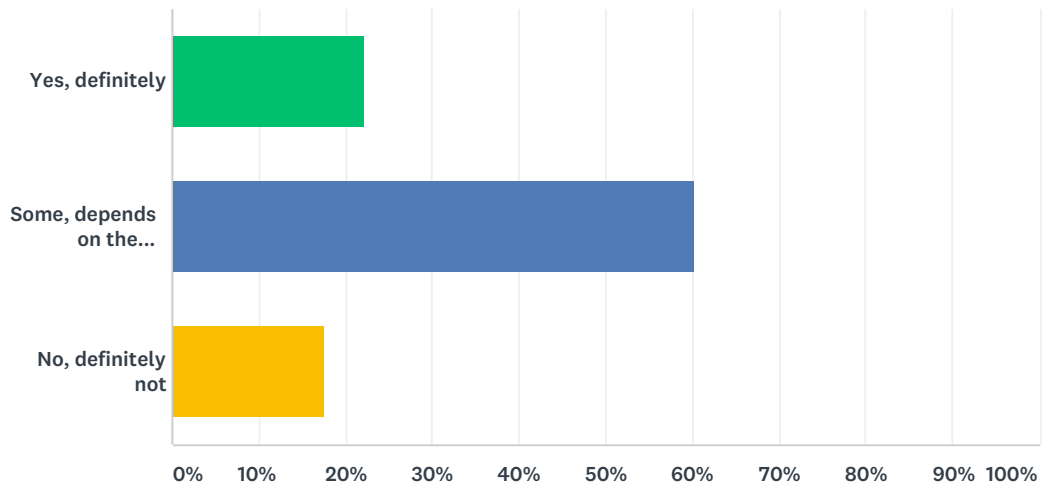

Q5 Do you think that people living doubled up should be counted as homeless?

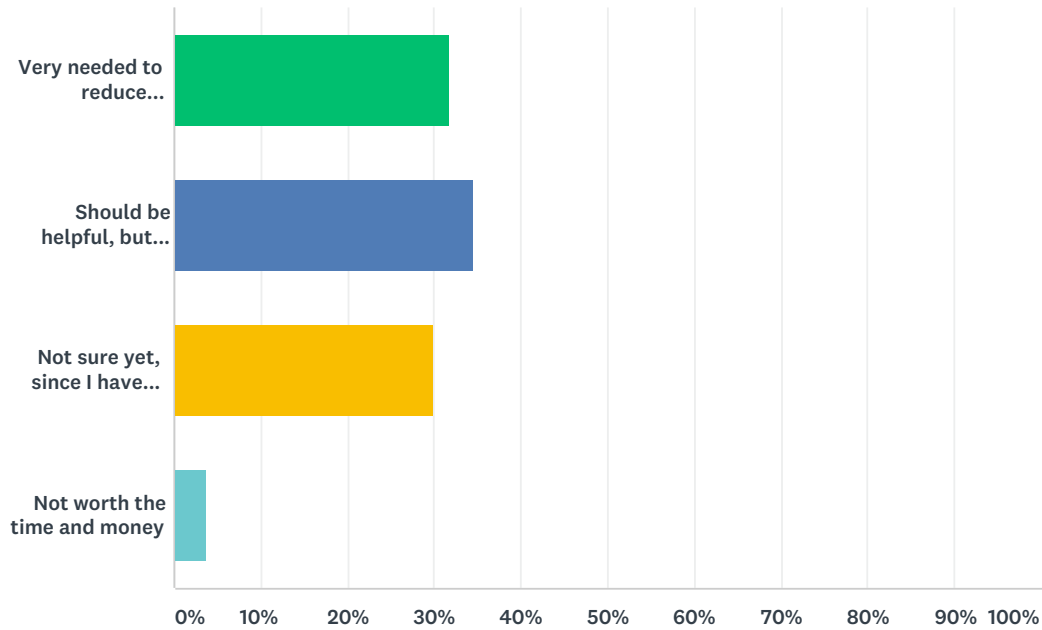

Q6 What is your opinion of the Coordinated Entry initiative?

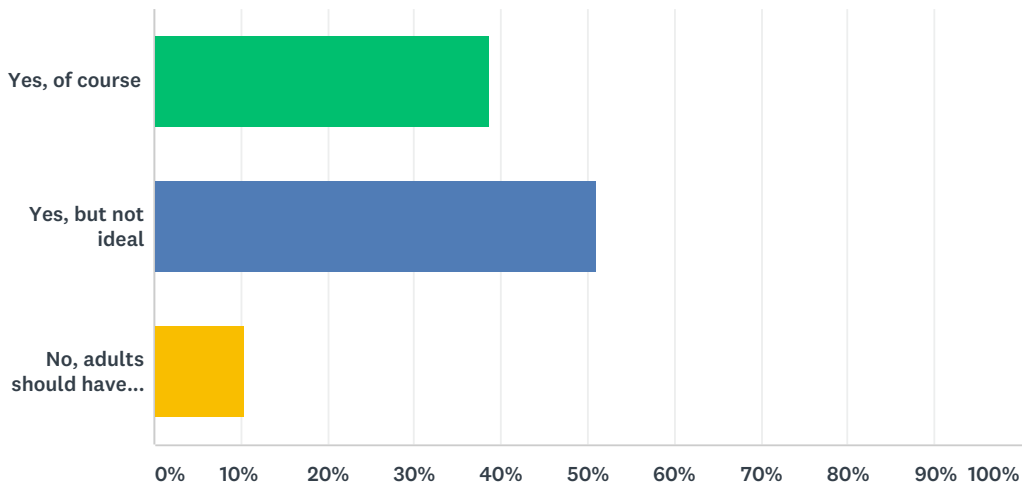

Q7 Do you think that homeless persons who move from a shelter to a shared-living apartment should be considered as permanently housed?

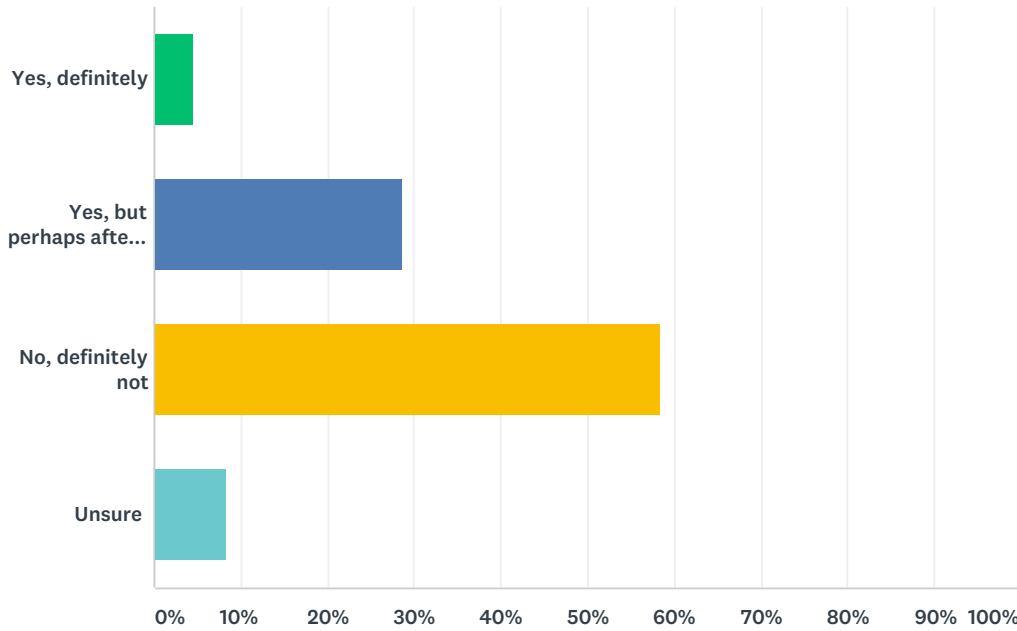

Q8 Do you think Emergency Shelters should charge small program fees for stays?

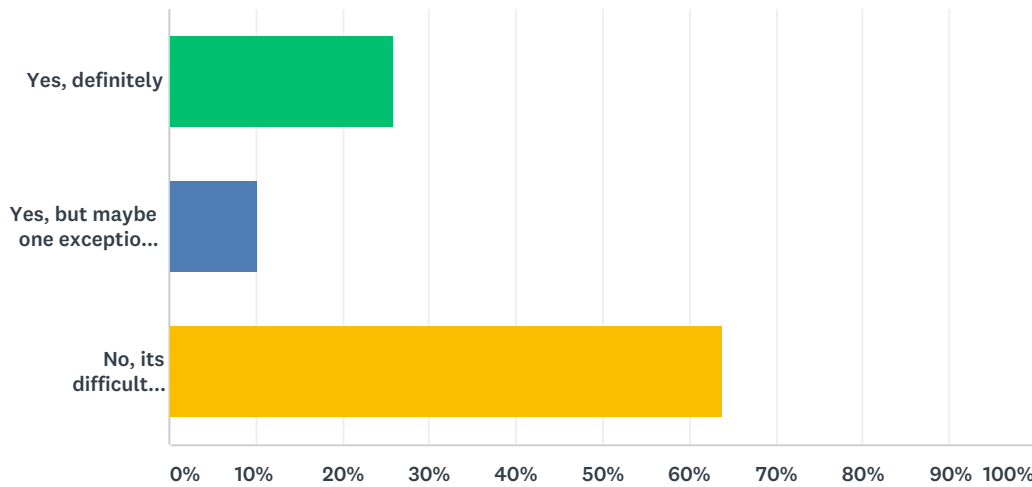

Q9 Do you think HUD should require that all emergency shelters require a bed frame to eliminate a "mats on a floor" layout?

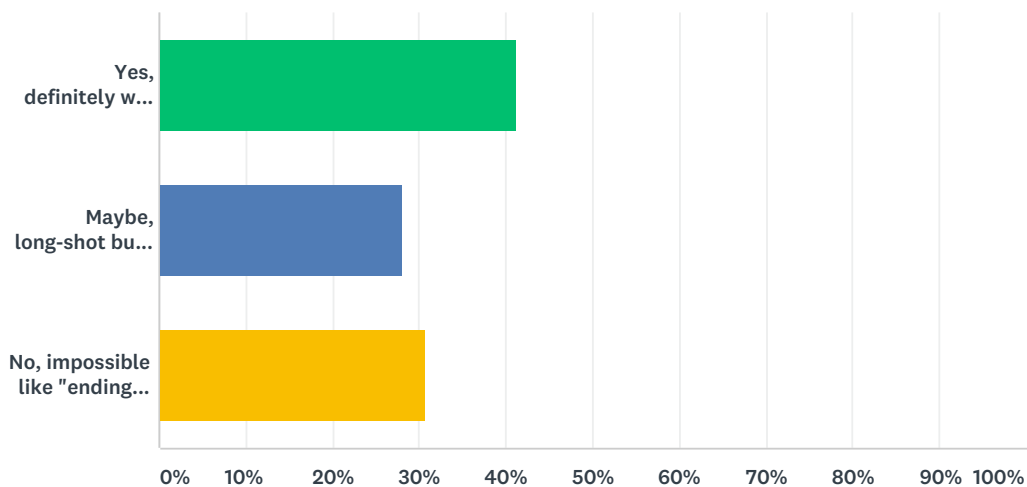

Q10 Do you think it is possible to end homelessness?

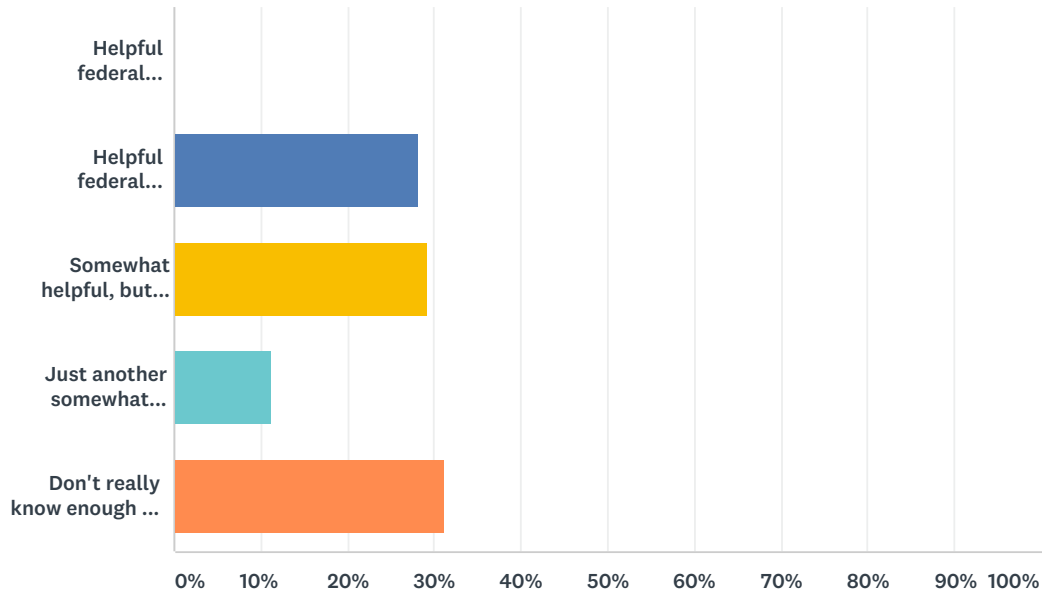

Q11 Which best captures your opinion of the US Interagency Council on Homelessness?

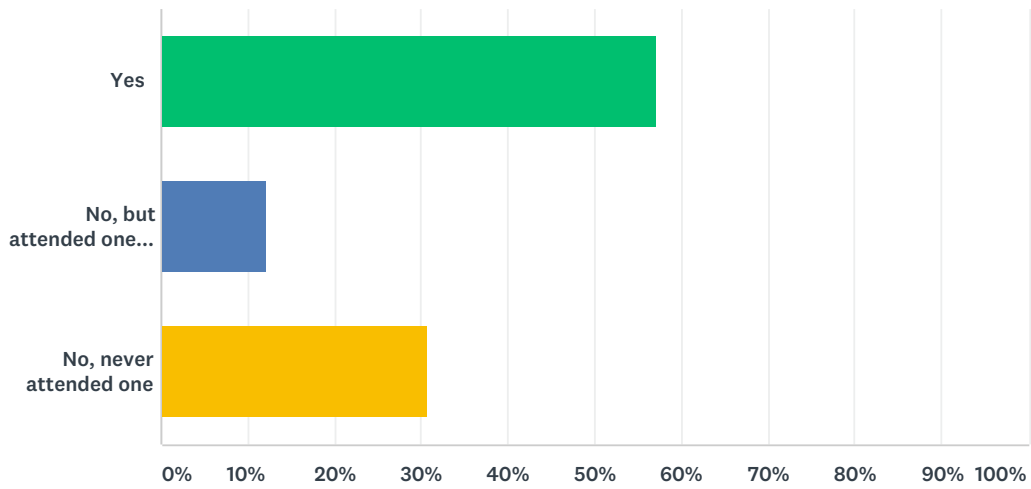

Q12 Have you attended a National or State Homeless conference in the past 3 years?

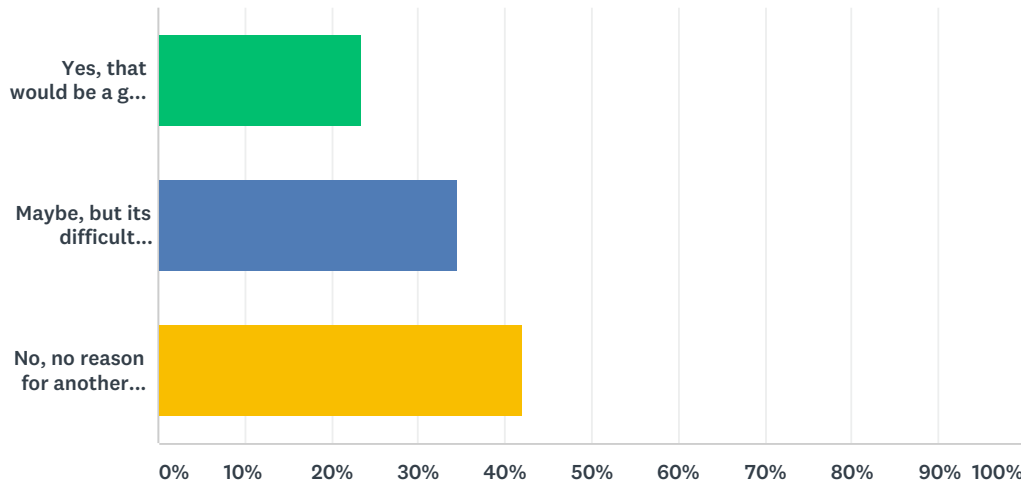

Q13 Do you think there should be a separate distinction for "super" chronically homeless persons, like those who have been homeless for more than 5 years?

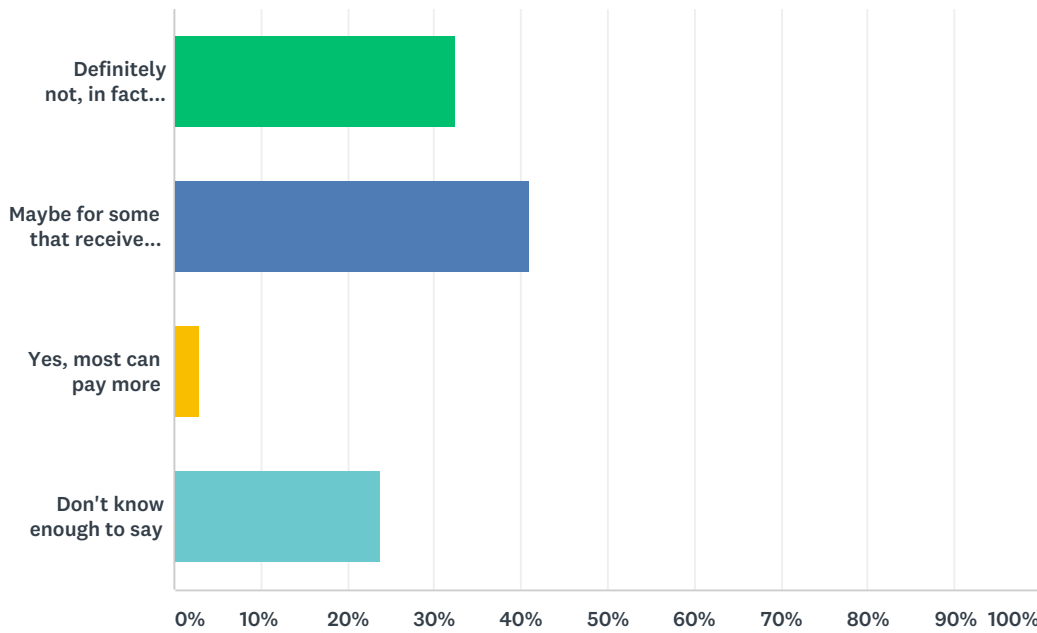

Q14 Do you think that people with housing subsidies should pay more than the HUD rent formula?

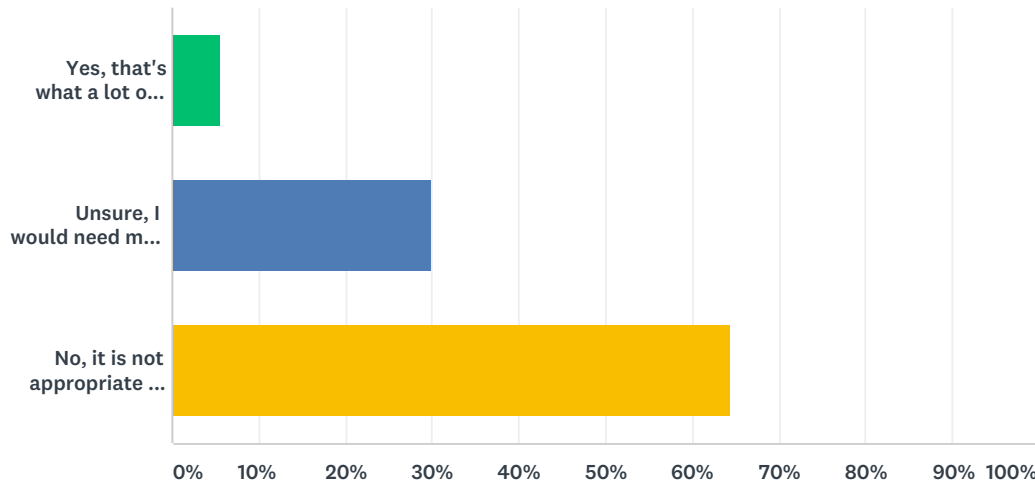
